

BOYS & GIRLS CLUBS' EARLY LEARNING CENTER INITIATIVE:

American Rescue Plan Act Investment Update



The Nevada Alliance of Boys & Girls Clubs is proud to share progress on our bipartisan-approved statewide initiative to expand early learning centers and child care access for Nevada families. In March 2024, Governor Joe Lombardo sponsored the initiative in partnership with Boys & Girls Clubs in order to expedite new child care seat availability statewide. The following month the legislature's Interim Finance Committee approved a \$16.7 million American Rescue Plan Act (ARPA) investment for the effort. The initiative funds 14 projects statewide, involving the collaboration of seven independent Boys & Girls Clubs organizations and their respective board of directors and community partners.

The funding will double the number of Boys & Girls Clubs early learning centers and provide an additional 1,000 children with quality day care, mental health enrichment and kindergarten-readiness activities. This is exactly what ARPA was created for – post-pandemic economic recovery projects to support hard working families.

An Initiative **Built on** Sustainability



The ARPA funding represents Boys & Girls Clubs, the governor and legislature's commitment to support working families by creating 1,036 new child care seats across 12 cities between now and 2026. As these sites are completed, Clubs will be seeking skilled child care workers to provide programming. In partnership with the Nevada Department of Employment, Training and Rehabilitation (DETR), we are actively creating a pipeline for qualified youth-friendly workers to ensure we operate at maximum capacity.

The initiative, **Up Next Nevada**, was launched in February 2025 to brace for the state's next economic boom and meet the trajectory of expanding our services and sites.

Up Next Nevada leans into the opportunities noted in the 2023 legislation of Assembly Bill 428, focusing on Gen Z career pathways in education, energy and health care. Boys & Girls Clubs' effort identifies 160 full-time employees, ages 18 to 24 years old, interested in one of these three career areas, adds professional development planning, tuition and/or trade reimbursement, and career mentorship.

Staff work with youth on academic tutoring and enrichment (education), science, technology, engineering and math programs (energy) and substance abuse and opioid misuse prevention programs as well as health, fitness and nutrition programs (health care). **Up Next Nevada** also supports 50 teens in college and career exploration while employing them as seasonal Clubhouse employees.

ARPA projects are shovel-ready and highly anticipated by employees in mining, trades, charter schools and local government. Paired with the Up Next Nevada initiative, we'll be able to recruit talent quickly and retain quality employees. These two publicprivate partnerships are a win-win, and our expansion to serve working families is a game-changing economic driver for both communities and employers.
